## 2. HORSE RECORDING

Recording your horse/pony automatically enters it in the USEF Horse of the Year Program provided the owner is an Active member of the Federation and USHJA (if applicable). Horses must be recorded to compete at certain USEF National Championships

### LIFETIME RECORDING (Required for Passports)

- Age discount requires proof of age (i.e. registration papers).
- \$35 Birth to December 31st of year foaled.
  - \$85 Horses one year of age (from January 1st to December 31st of the first year after foaling).
  - \$160 Horses two years of age (from January 1st to December 31st of the second year after foaling).
  - \$200 Horses three years of age or older.

### ANNUAL RECORDING

- \$75 2017 Recording (expires on November 30, 2017)
